CONSTITUTION: Did you know that the TDXS has a honest-to-goodness constitution? We sure do and the Board of Directors constantly refers to this document during their meetings. We have taken on many new members since our sacred parchment was last published in the Bullsheet. A Copy is attached to this months mailing. Please stick this copy away with your other radio keepsakes. In this document are answers to many of the questions that seem to pop-up at meetings. The most common question and source of confusion is the method in which one becomes a member of the TDXS. Please take a moment to commit at least that portion of your constitution to memory. Much embarassement can be avoided if we follow the guidelines.

EDITORIAL: Now I get to exercise the privilege of editorship. Even the big newspapers allow their editors a few paragraphs to babble on and create the flow of enzymes and discussion. I have been accused in the past of printing things that others talk about under there breath but not for public consumption. I do this because I believe that some things need to be said and aired. But lets not become one of the multi-hundred member clubs that fades into history because of so much dead weight and controversy. The constitution says candidates for membership should demonstrate an interest in DX or contesting activities. If the person doesn't - don't nominate him and/or don't vote YES.

Before the bombs start coming through my window, let me state that I personally know for a fact that all the fellows mentioned earlier as candidates for membership meet the intent of the TDXS Constitution.

Texas DX Society Constitution

Article I

Name

The name of this organization is the Texas DX Society.

Article II

Purpose

The primary objective of the Society is to stimulate and pursue the hobby of amateur radio dx and contest activities.

Article III

Officers

Section 1. The elected officers of this club shall be: President, Vice President, Secretary and Treasurer.

Section 2. The appointed officers of this club shall be: Contest Chairman, Field Day Chairman, Repeater Chairman, Legal Chairman, DX Chairman and Communications Chairman.

Section 3. Vacancies in an elected office will be filled by the Board of Directors. Vacancies in an appointed office will be filled by the Executive Committee.

Section 4. The term of office shall be one calendar year (January 1 through December 31).

Article IV

Board of Directors

Section 1. The Board of Directors shall consist of the four elected officers and the six appointed officers.

Section 2. The Board of Directors shall have the power to transact any business of an immediate nature that occurs between regularly scheduled meetings by a majority vote with at least six

members voting. Such decisions shall be reported at the next regular club meeting.

Section 3. The Board of Directors shall meet when the President deems it necessary upon notice to the board members. Six members will constitute a quorum.

#### Article V

##### Executive Committee

The Executive Committee shall consist of the four elected officers, and shall by majority vote appoint the appointed officers.

#### Article VI

##### Election of Officers

Section 1. Written nominations for each of the four elected officers shall be made to the club Secretary. The nomination period shall begin with the regular September meeting and end with the regular October meeting. Additional nominations shall be accepted from the floor during the regular October meeting.

Section 2. Election of officers shall be by secret ballot at the regular November meeting. Notice of the election shall be mailed to each regular club member by November 1. Absentee ballots shall be accepted by the club Secretary until twenty-four hours prior to the meeting. The Executive Committee members who are in attendance shall count the ballots. The election results shall be decided by a simple majority vote for each office.

Section 3. A runoff election shall be held between the top two candidates for any office in which no candidate receives a majority vote.

Section 4. The elected officers shall be introduced at the regular December meeting and shall officially take office on January 1.

## Article VII

### Dues

Section 1. The annual dues shall be determined by the Board of Directors each October and presented to the club for approval at the next scheduled meeting at which a quorum exists.

Section 2. The dues are payable on or before the first regular meeting in January of each year.

Section 3. Any member who is more than 60 days past due on his annual dues can be dropped from the membership by the Board of Directors.

## Article VIII

### Club Treasury

Section 1. The disposition of club money shall be decided by a 3/4 favorable vote of the members voting during a regular or special club meeting in which a quorum exists except as outlined in Article VIII, Section 2.

Section 2. The Board of Directors can authorize small appropriations not to exceed \$50.00 at any one time and not to exceed \$200.00 for a yearly period.

Section 3. The fiscal year shall be January 1 through December 31.

## Article IX

### General Business

All general business shall require a majority vote during a meeting in which a quorum is present.

## Article X

### Constitution Changes

Section 1. Each proposed constitutional change shall be submitted to the Secretary in writing.

Section 2. Each proposed constitutional change shall be read to the members at the next regular club meeting.

Section 3. Each constitutional change shall be presented to the full membership and receive a 2/3 favorable vote of the full membership to pass.

## Article XI

### Membership

Section 1. Membership in the Texas DX Society is open to any amateur radio operator who: has demonstrated an interest in DX or contest activities, holds a valid amateur license and is duly nominated and elected according to the procedures set forth in Article XII.

Section 2. A full member is an individual who meets the criteria of Article XI, Section 1 and attends at least FOUR regular meetings a year. A full member is entitled to vote on all issues before the Society, hold office, be a member of the Board of Directors and be chairman of a committee. The previous years attendance record shall determine membership status of the current year. New members shall attend 33% of the remaining meetings to be qualified for the coming year.

Section 3. An associate member is an individual who has met the criteria of Article XI, Section 1 but who has not attained the minimum meeting requirement. An associate member shall be reinstated as a full member by the Board of Directors if he attains the minimum meeting requirement. An associate member cannot vote on issues before the Society nor hold elected office or appointed office.



## Article XII

### Method of Electing Members

1. The name and application of a prospective member, proposed by a full member, shall be submitted in writing to the Board of Directors through the club Secretary.
2. The Board of Directors shall consider the eligibility and qualifications of the proposed member in closed session and notify the proposer through the club Secretary of its decision.
3. If the decision is favorable, the proposer shall formally introduce the prospective member at a regular meeting.
4. Thirty days after introduction, the Secretary shall mail ballots to all full members.
5. A favorable vote of 75% with at least 50% of the members voting shall be necessary for election.

## Article XIII

### Meetings

Section 1. Regular meetings shall be held on the second Friday of each month except as outlined in Article XIII, Section 4, at a time and place set forth by the Board of Directors. In the event that the meeting conflicts with another activity of interest to many Society members, the Board of Directors may designate the preceeding or following Friday as an alternate meeting night.

Section 2. Special meetings may be called by the President after polling the Board of Directors.

Section 3. A quorum for regular and special meetings shall consist of 25% of the full member membership and must include the

President or Vice President and any three members of the Board of Directors.

Section 4. The regular December meeting shall be held during the month of December at a time and place set forth by the Board of Directors.

#### Article XIV

##### Duties of Officers

Section 1. The President shall preside at all meetings of the Society and the Board of Directors and shall represent the Society at all times and shall perform all other duties pertaining to that office.

Section 2. The Vice President, in the absence of the President, shall perform the duties of the President and shall be in charge of the meeting programs.

Section 3. The Secretary shall keep an accurate record of all regular, special and Board of Director meetings, shall keep attendance records for meetings and shall keep all records pertaining to this office.

Section 4. The Treasurer shall be custodian of all funds, shall keep auditable records, collect dues, pay all bills as approved by the Society and/or the Board of Directors, and shall render a monthly statement and an annual report.

Section 5. The appointed officers shall have duties and responsibilities as determined by the Executive Committee.
